- 4. Legitimate Interests (Article 6(1)(f) GDPR): We may process data to improve our Services, balancing our interests with the rights and interests of users, guaranteeing responsible data use.

## **Purposes of Use of Personal Data and Legal Basis**

a) When using our services, you connect your wallet to AutoLayer through platforms like MetaMask and Zerion. We prioritize data protection and adhere to strict measures in compliance with applicable laws. While connecting your crypto wallet, please be aware that the relevant wallet provider may collect some personal data. It's important to note that AutoLayer is not responsible for any personal data processing during the wallet connection process.











**b)** In our dApp, we use cookies and tracking tools to enhance your experience and provide personalized content. While our dApp doesn't primarily use cookies, some additional scripts loaded through Tag Manager may use them for specific functions. You can manage these cookies in your device settings to control your privacy preferences.
